A) <u>Pre-Assessments</u> (on-site)

A pre-assessment is a baseline evaluation of client's site to determine the requirements to comply with Occupational Health & Safety Act No. 85 of 1993 in the workplace. (Risk assessment available on requests as per industry.)

B) Audits (on-site)

An OHS Audit is carried out by an auditor (inspector) on-site for large entities and a self-audit solution is available for small to medium sized corporate entities. After inspection walk-through has been conducted, client receives a comprehensive report including identified deviations and recommendations to apply corrective measures.

Audits consist of 6 main sections:

- I. Document audit.
- II. Physical audit.
- III. Photographic evidence.
- IV. Product identification.
- V. Signage identification.
- VI. Order form.

A star graded certificate is issued, valid 1 (one) year to corporate environment entities and 6 (six) months to warehousing, factories, production, engineering or manufacturing entities.


